GAO examined income and asset reporting by Medicaid recipients in nursing homes to determine the: (1) effectiveness of states policies and procedures for verifying savings bond holdings; and (2) extent of holdings of recipients residing in Massachusetts nursing homes. GAO found that: (1) as of April 1986, 143 Medicaid nursing home residents in Massachusetts had savings bond holdings in excess of the 2, 000 statutory limit; (2) the residents had outstanding bonds worth a total of about 1. 5 million, with individual holdings ranging from 2, 000 to over 60, 000; (3) 48 of 57 recipients records did not disclose bond ownership or redemptions, while 1 made partial disclosure; (4) the 49 individuals should have been disqualified from receiving Medicaid benefits for filing false or incomplete applications; and (5) states did not have access to the Department of the Treasurys savings bond data files to verify individual Medicaid applicants and recipients bond holdings or redemptions.
