B-285057 The section intervened on behalf of the plaintiffs in two cases to defend the constitutionality of laws passed by Congress, referred to as Seminole 13 Tribe type cases. These particular cases drew into question the constitutionality of Title VII and the Equal Pay Act as applied to the state of Alabama. For example, in one of these cases, the defendant, a state university, asserted that Congress exceeded its authority when it extended coverage of Title VII and the Equal Pay Act to the states. Thus, the defendant argued immunity from claims of discrimination set forth in these statutes. The section intervened in these cases because the Attorney General and the Assistant Attorney General have designated these types of cases a Justicewide priority. Seminole Tribe type cases represent a body of casework within the Division and the Department of Justice. According to the section chief, the Attorney General convened a task force to coordinate all Department of Justice casework related to Seminole Tribe issues.
